**It was during Ambassador Leo Wanta's ILLEGAL imprisonment in Oklahoma that the Clinton-Bush Crime Family ILLEGALLY removed Wanta's name from the Marvelous Investments Ltd. CIA proprietary headquartered in Andover, Massachusetts.**

**P.S. There are NO more secrets of 9/11. We can now let the name of TRAITOR Dov Zakheim again surface.**

**ZIONIST Zakheim, who worked in the Pentagon on 9/11 as a controller, can now be directly fingered in taking \$7 TRILLION of U.S. Taxpayers' money, i.e. the Wanta-Reagan-Mitterrand Protocols funds, out of the Pentagon just prior to 9/11;**

**Tim Osman aka Osama bin Laden actually did patriotic work for the United States in the matter of the Russian ruble operation in the 1980s, which brought down the Soviet Union, and also worked to help remove the Soviets from Afghanistan, i.e. his leadership of the U.S. financed Mujahadeen.**

**Osman aka bin Laden, accordingly became a convenient patsy to blame 9/11 on so Bushfraud and his criminal thugs could freeze his CIA proprietary accounts tied to the Wanta-Reagan-Mitterrand Protocols and quickly move the United States of America towards martial law.**

**No surprise folks, the Tim Osman aka Osama bin Laden proprietary accounts were held at none other than Lehman Brothers.**

**Also, the 9/11 BLACK OP False Flag attack on the Pentagon conveniently killed numerous accountants and auditors and destroyed financial evidence contained in audit records.**

**Of course, it was a missile not an airplane that hit the Pentagon.**

**P.P.S. Israeli ZIONIST Dov Zakheim had worked for the TriData Corporation in the 1990s and oversaw the investigation of the original 1993 WTC terrorist attack.**

**Accordingly, Zakheim knew every inch of the World Trade Center.**

**Eventually the World Trade Center hired a security firm named Securacom, a Kuwait-American owned company, to operate the security system at the World Trade Center.**

**The CEO for the company was none other than Marvin Bush -- Bushfraud's younger brother.**

**Marvin Bush later changed the name of the firm from Securacom to Stratosec and de-listed Securacom from the New York Stock Exchange in early 2002.**

**Zakheim actually conspired with Chinese, Israeli and British Intelligence and American TRAITORS Bill and Hillary Clinton, as well as ratfink and neocon, current Connecticut Senator Joseph Lieberman, to institute an espionage operation against the American People called "Operation Orpheus".**

**Orpheus, a precursor to the Bush-Clinton-Mossad-Gary Best "TRUE COLOR" assassination teams, engaged in a massive surveillance program directed against the American People on the behalf of Israeli, Chinese and British Intelligence.**

**The British term for the espionage program was named "Project Echelon", which was used by British MI6 to conduct industrial spying against the Republic of France and its U.S. based embassy and consulates.**

**The New York Times continues to kill this story based on the bogus William Cohen instigated information sharing policy, which as crazy as it sounds, is classified under national security.**

**Again, let's get back to Zakheim.**

**Zakheim, who also worked for a Washington, D.C. defense consulting corporation, Booz Allen Hamilton, actually helped contract and lease from the Pentagon the purchase by the state of Israel of thirty-two (32) 767 aircraft that were later refitted in Israel at a base in Haifa 30 days before 9/11.**

**United Flight 175, which hit the south tower of the World Trade Center, had a flight termination system model consistent with the shape and size tied to the fuselage of a 767 that was actually refitted 30 days before 9/11 in Haifa, Israel.**

**The refueling equipment on United Flight 175 is almost an exact replica of the type of equipment that these leased 767s had placed on them while in Haifa, Israel in early August of 2001.**

**Back to Operation Orpheus, which was a precursor to the Bush-Clinton-Mossad-Gary Best "TRUE COLORS" assassination teams.**

**Operation Orpheus continues to operate as a SECRET Pentagon-NSA sponsored program, which employs Israeli MOSSAD as assassins in Iraq, whose goal is to murder and eliminate all tribal leaders of a potential new Sunni insurgency, which would be directed against the U.S. backed Shiite government of Iraq.**

**The Israeli Mossad are trained in what is now known as Northern Kurdistan, a province of Iraq, which borders the nation of Turkey.**

**One final note: The current FBI Division 5-Israeli Mossad espionage operation against the American People, along with control of the American media, continues with its base of operations being the Tom Brokaw linked Division 5 William Morris Agency of Denver, Colorado, an Israeli Mossad outpost in Boca Raton, Florida as well as the University of Southern California in Los Angeles.**

**USC, a noted CIA recruiting center going back to the late 1950s, uses its law school as a nest to recruit and hire such TRAITORS and conspirators.**

**Noted Mossad agent and FOX News consultant, serial loser Susan Estrich is one of these types.**

**She is a direct enemy of duly elected President Albert Gore Jr. and has total loyalty to the criminal Israeli Mossad and the Bush-Clinton Crime Family Syndicate.**

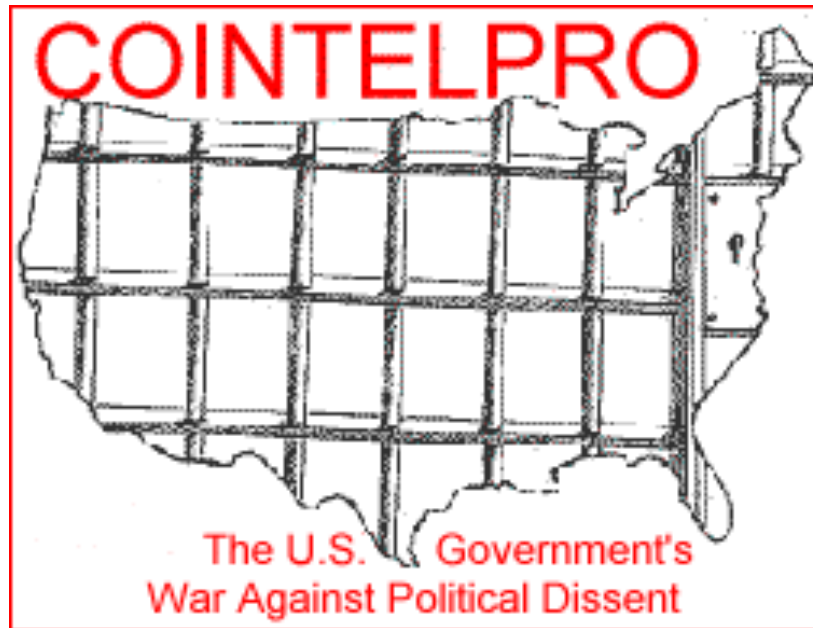
