
East German DVD-Mossad Deutsche Bank and \$TRILLIONS in derivatives tied to U.S. based Wachovia Bank

Section 101(a)(1) of the "Emergency Economic Stabilization Act of 2008" (EESA), creates the "Trouble Asset Relief Program" (TARP), which provides:

#### H.R.1424

SECTION 101. PURCHASES OF TROUBLED ASSETS.

- (a) Offices; Authority .--
- (1) Authority.--The Secretary is authorized to establish the Troubled Asset Relief Program (or ....TARP") to purchase, and to make and fund commitments to purchase, troubled assets from any financial institution,.. [word "any" enhanced]

SECTION 204 of the "Emergency Economic Stabilization Act of 2008" (EESA), puts the United States under emergency economic rule; it states the following:

"All provisions of this Act are designated as an emergency requirement and necessary to meet emergency needs..."

<u>P.S.</u> All of this, of course, folks, is totally UN-Constitutional and leaves the American People with NO choice but to declare the entire U.S. occupation government as contemptuous and without any more legal authority to direct the lives of the American People.







Wilcox is well connected to a noted 9/11 linked alleged Al Qaeda-Deutsche terrorist cell, code named 'Becker'.










